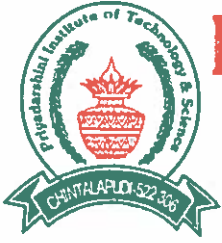

- Rates for recyclables will be displayed time in time on Nagamalleswari Scrap Trader.
- Priyadarshini institute of Technology and Science will raise invoices of the value to be received against the disposal of recyclables. The sustainability certificate for responsible disposal through the Nagamalleswari Scrap Trader will be provided and the same can be accessed on Nagamalleswari Scrap Trader dashboard.
- Priyadarshini institute of Technology and Science is required to provide necessary entry and exit permissions included. But not restricted to gate-pass, other access formalities to use its space for loading of recyclable and man power movement during the time of pickup.

3. Indemnity:

Term:

This Agreement shall come into force from the date of signing and remain valid for a period of one year, including final payment & documentation whichever is earlier unless terminated earlier by the Parties. The Agreement may be extended for such further periods and quantities as may be agreed to by the parties.

4. Termination:

This Agreement shall automatically terminate on the expiry of the period

- (1) One year from the date of signing of this Agreement or completion of the project. Including final payment & documentation, whichever is earlier as provided above unless extended by the Parties by mutual consent?
- (2) Parties may terminate the Agreement after giving a notice in writing of thirty (30) days to the other Party of its intention to terminate the Agreement.
- (3) In the event of any lapses in execution by any party, the other party shall have the right to terminate this agreement by giving a 30 days' notice to the defaulting party.

5. Amendment:

Any Amendment to this Agreement shall be valid and binding on the Parties only if it is made in writing and signed by duly authorized representatives of each party.

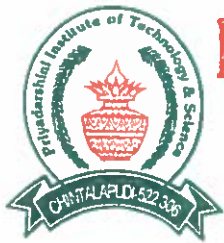
7. Governing Law and Jurisdiction:
