It is reconstituted as LA&IC (Lady Advisory and Internal Committee) from 2019.As per vide order dated 12-05-2023 by the Hon'ble Supreme Court of India, it is reconstituted as IC/ICC (Internal Committee/Internal Complaints Committee) from July,2023, to address issues and complaints regarding sexual harassment

Objectives:

- 1) The main objective is to implement Prevention of Sexual Harassment (PoSH) Act, 2013.
- 2) To promote an environment free of sexual harassment and other acts of gender based discrimination at the College that ensures gender equality and equal opportunities.
- 3) To prevent sexual harassment and to promote the general well being of female students, teaching and non-teaching women staff of the College.
